Emergency Services-Leon- Chair Leon reported on the progress at the Emergency Services Building. Concrete pads will be poured this week in the front of that building, drywall is finished and painting is proceeding. This will be on the next council meeting for a vote.

<u>Mayoral Report:</u> Mayor pro tem Hunt asked council to all take a look at the property the Garrett's have asked to have vacated on South Elm Street so this can be voted on in the next meeting.

The second property that should be looked at by all members before the next meeting is the land adjacent to Larry Harper's residence on Harrison Street. He has asked the city to vacate what was to be an extension of Richman Street, which will never happen due to costs and logistics. This will be on the next meeting for a vote. A request for legalizing golf carts on the city streets has been brought up. There is information in the packets about the statute 625KC5-11-14262.1 and 1426.2. This will be put to a vote on the next meeting agenda.
