**AN ORDINANCE AMENDING CHAPTER 78 "PARKING SCHEDULES"
OF THE MUNICIPAL CODE OF THE CITY OF VILLA GROVE
REGARDING PARKING ON RAILROAD STREET**

WHEREAS, the City of Villa Grove, Douglas County, Illinois, is a municipality as contemplated under Article VII, Section 7 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of City's powers and functions as granted in the same; and

WHEREAS, the City of Villa Grove has heretofore codified its municipal ordinances in the City of Villa Grove, Illinois Code of Ordinances; and

WHEREAS, Chapter 78 thereof, entitled "Parking Schedules" includes various public streets and locations where parking of motor vehicles is regulated or prohibited in some manner and in some circumstances; and

WHEREAS, the City has received a request from a local small business concerning parking on portion of Railroad Street for extended time periods, thereby reducing the access to such business, and ; and

WHEREAS, the Mayor and City Council have determined that the following ordinance amendment affecting parking on Railroad Street is in the public interest, promotes public safety, and should be enacted.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL, CITY OF VILLA GROVE, DOUGLAS COUNTY, ILLINOIS, as follows:

SECTION 1: The following provisions of Chapter 78: Parking Schedules, Schedule I. "Parking Restrictions" are hereby added, regarding parking restrictions on Railroad Street:

Street: Railroad Street

Location: From the intersection with South Oak Street east to the intersection with the alley running north-south between South Oak and South Main Streets

Prohibited Times: All parking shall be limited to 3 hours (except for official Emergency vehicles used at any time)

Side: North Side of Railroad Street

SECTION 2: Violations of this ordinance subject the violator to the penalty provisions of Section 70.99 of the Villa Grove Code of Ordinances.

SECTION 3: This ordinance shall be effective upon its passage, approval and publication in pamphlet form, pursuant to law and the erection of appropriate signage by the City's Public Works Department.

SECTION 4: Except as herein provided, the provisions of Schedule I "Parking Restrictions" of Chapter 78 "Parking Schedules" of the City of Villa Grove Code of Ordinances shall remain in full force and effect.
