CALL TO ORDER—ROLL CALL

The City Council of the City of Villa Grove met in regular session on Monday, May 14, 2018, in Council Chambers. Mayor Eversole-Gunter called the meeting to order at 6:00 p.m. Roll call found the following members present: Alderman Leon, Cheely, Blaney, Griffith, Allen, Stipp, and Junior Alderman Gulick. Junior Alderman Shunk was not present. Clerk Osborne and Department Managers Athey, Craig, and Chief Gire, and Arbuckle, Trudeau, and Fire Chief Elston were also present.
