**AN ORDINANCE ASSIGNING A PROPERTY ADDRESS TO REAL ESTATE  
LOCATED OF 109 MAGNOLIA DRIVE, VILLA GROVE, DOUGLAS COUNTY, ILLINOIS  
(FORMERLY KNOWN AS 105 MAGNOLIA DRIVE)**

**WHEREAS**, the City of Villa Grove, Douglas County, Illinois, is a municipality as contemplated under Article VII, Section 7 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of City's powers and functions as granted in the same; and

**WHEREAS**, Section 11-80-18 of the Illinois Municipal Code (65 ILCS 5/11-80-18) provides that corporate authorities of each municipality may regulate the numbering of buildings and lots; and

**WHEREAS**, Section 11-80-19 of the Municipal Code (65 ILCS 5/11-80-19) provides that the corporate authorities of each municipality may name originally and then change the name of any street, avenue, alley, or other public place; and

**WHEREAS**, it has come to the attention of the City of Villa Grove that certain numbering on Magnolia Drive can be confusing with two addresses using number 105; and

**WHEREAS**, upon investigation and reflection, the City Council has determined that Lot 62 of Country Club 2nd Addition to the City of Villa Grove, Illinois (hereinafter "Lot 62") be assigned the address of 109 Magnolia Drive to reduce confusion; and

**WHEREAS**, in accordance with Section 11-80-19, no change in the name of any street, avenue, alley or other public place is effective until 30 days after the corporate authorities give notice of such change to the election authorities having jurisdiction in the area in which the name of the public place is changed and the post office branch serving that area.

**NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL, CITY OF VILLA GROVE, DOUGLAS COUNTY, ILLINOIS, as follows:**

SECTION 1: Incorporation Clause. The Mayor and City Council of the City of Villa Grove, Illinois hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this ordinance.

SECTION 2: Purpose. This Ordinance is to assign a new street address to what will be known as 109 Magnolia Drive.

SECTION 3: Action. Lot 62 of Country Club 2nd Addition to the City of Villa Grove situated in Douglas County, Illinois bearing PIN 04-03-11-109-004 is hereby assigned the street address of 109 Magnolia Drive, Villa Grove, Illinois.

SECTION 4: State law Adopted. All applicable provisions of the Illinois Compiled Statutes, including the Illinois Municipal Code, as may be amended from time to time, relating to the purposes of this Ordinance are hereby incorporated herein by reference.

SECTION 5: Approval and Execution of Documents. The Mayor and City Administrator are hereby authorized and directed to execute any and all other documents necessary to carry out and give effect to the purpose and intent of this Ordinance. The City Administrator is directed to provide a copy of this Ordinance to the Douglas County E911 Coordinator, the U.S. Postal Service, and to any other appropriate corporate authority.

SECTION 6: Other Actions Authorized. That the Mayor and City Clerk and City Attorney are hereby authorized and directed to do all things necessary, essential, or convenient to carry out and give effect to the purpose and intent of this Ordinance.

SECTION 7: Acts of City Officials. All acts and doings of the officials of the City, past, present and future which are in conformity with the purpose and intent of this Ordinance, are hereby in all respects, ratified, approved, authorized and confirmed.

SECTION 8: Headings. The headings for the articles, sections, paragraphs and sub-paragraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provisions of this Ordinance.

SECTION 9: Severability. The provisions of this ordinance are hereby declared to be severable and should any provision, clause, sentence, paragraph, sub-paragraph, section, or part of this ordinance be determined to be shall be excluded and deemed inoperative, unenforceable, and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect. It is hereby declared to be the legislative intent of the City Council Members that this Ordinance would have been adopted had not such unconstitutional or invalid provision, clause, sentence, paragraph, sub-paragraph, section or part thereof had not been included.

SECTION 10: Superseder and Publication. All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded. A full, true and complete copy of this ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the City as provided by the Illinois Municipal Code, as amended.

SECTION 11: Effective Date. This Ordinance shall be in full force and effect upon passage and approval, as provided by the Illinois Municipal Code, as amended.
