**AN ORDINANCE AMENDING SECTIONS 91.05 AND 91.06 OF TITLE IX,
CHAPTER 91 OF THE MUNICIPAL CODE OF THE CITY OF VILLA GROVE
(REGARDING ANIMALS)**

WHEREAS, the City of Villa Grove, Douglas County, Illinois, is a municipality as contemplated under Article VII, Section 7 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of City's powers and functions as granted in the same; and

WHEREAS, the City of Villa Grove has heretofore established ordinances which establish and regulate the treatment of animals; and

WHEREAS, the City's Board of Health set 6:30 p.m. on Tuesday, April 2, 2019, at the City Hall, 612 Front Street, Villa Grove, Illinois, as the time, place and agenda for such public meeting posted as required under 5 ILCS 120/2.02(a), which such public meeting was held and conducted at such time and place and thereafter completed and closed on such date.

WHEREAS, the City's Board of Health has determined that certain changes of the Municipal Code should be recommended to the Council which they believe are, in consultation with the City Attorney, in the best interests of the City.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL, CITY OF VILLA GROVE, DOUGLAS COUNTY, ILLINOIS, as follows:

SECTION 1: Title IX, Chapter 91, Section 91.05 of the Municipal Code of the City of Villa Grove is hereby amended to read as follows:

91.05 BUTCHERING OF ANIMALS. It shall be unlawful to kill for domestic use or for the purpose of selling for meat any cattle, calves, sheep or hogs within the corporate limits of the city.

SECTION 2: Title IX, Chapter 91, Section 91.06 of the Municipal Code of the City of Villa Grove is hereby amended to read as follows:

91.06 MAINTAINING CERTAIN ANIMALS RESTRICTED. It shall be unlawful to keep or maintain any hogs, rabbits, horses, cattle, chickens, turkeys, geese, ducks or other like fowl within the corporate limits of the city.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: That all ordinances, resolutions and order, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

SECTION 5: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law, and shall be published in pamphlet form pursuant to law.
