**ENGINEERING REPORT-**Ándy Kieser updated on the scrubber issue. The manufacturers will replace one of the media that is the high absorbency and will add fans to help the media work more efficiently. The first tests on the new set up will be in February to see how it is working. The Front Street bridge repair will happen when it warms up, but will need to be coordinated at a time when the Route 130 bridge construction is not also happening due to traffic concerns. The Route 130 bridge work has to wait until the water goes down to allow access. Easements for the crosswalk on Rte. 130 are in place. The EPA has approved to put the new mains in the McCoy addition in the front easement area for better access for maintenance.
