CALL TO ORDER—ROLL CALL

The City Council of the City of Villa Grove met in regular session on **Monday, May 26, 2020** in Council Chambers. Clerk Osborne, City Administrator Athey, and Public Works Director Arbuckle, and City Attorney Marc Miller were also present. Council followed all COVID 19 protocols for social distancing.

PLEDGE OF ALLEGIANCE - The Mayor stood and led all attendees in The Pledge of Allegiance.

PUBLIC COMMENTS-Ag Days Chairman Bruce Allen reported they are still waiting to make the decision about holding Ag Days, but also asked if the City had a definitive answer right now. It was agreed to wait until the next meeting to determine what will happen.

ENGINEERING REPORT-Andy Kieser was not in attendance. Scott Arbuckle reported on the status of the sewer plant and McCoy. There were more repairs required at MCCoy and Scott asked about moving forward with the replacement of lines there. Consensus was also given to pay for the repairs to the sewer plant boiler at a cost of \$7200.

ATTORNEY REPORT-Marc Miller gave some information about ordinance considerations for windmills, solar power, and cannabis, stating there will need to be public hearings on the zoning for all of these items before voting on the ordinances. The zoning meetings are planned for later in June 2020. Mr. Miller also stated that the water analysis study being done by Mr. Gerald Hartman, a professional engineer who is only 1 of 20 in the US who have the capability to appraise water and sewer systems, will let the council know what systems they have, evaluation of the systems and their worth, and will present recommendations for moving forward.

MAYORAL REPORT-The Mayor reported on improvements happening at El Rancho Grande on Main Street. They will be expanding to the south to the lot where Pete's coin ship used to be. this will become an outdoor garden area for them. The Mayor also noted that a decision about the fireworks needs to be made before May 31, 2020.
