**ORDINANCE AMENDING SECTIONS 155.030(C) AND 155.126 OF THE  
ZONING CODE AND ADDING CHAPTER 157**

1. **PURPOSE:** The purpose of this Ordinance is to amend Section 155.126 of the Villa Grove Zoning Code pursuant to Section 11-13-26 of the Illinois Municipal Code (65 ILCS 5/11-13-26) which provides that “[a] municipality may regulate wind devices within its zoning jurisdiction and the 1.5 mile radius surrounding its zoning jurisdiction.”
2. **SECTION 155.030(C):** : The City Council upon a majority vote after proper notice and public hearing before the Plan Commission hereby amends Section 155.030(C) of the Zoning Code of the City of Villa Grove, Illinois of 1969 to add subsection (27) as follows:  
  
“155.030(C)(27) Wind Energy Conversion Systems subject to compliance with Chapter 157 Wind Energy Conversion System Ordinance”
3. **SECTION 155.126GG:** The City Council upon a majority vote after proper notice and public hearing before the Plan Commission hereby amends Section 155.126 of the Zoning Code of the City of Villa Grove, Illinois of 1969 to add Section GG to subsection 155.126 as follows:  
  
“(GG) Wind Energy Conversion Systems subject to compliance with Chapter 157 Wind Energy Conversion System Ordinance”
4. **CHAPTER 157:** The City Council upon a majority vote after proper notice and public hearing before the Plan Commission hereby the Zoning Code of the City of Villa Grove, Illinois of 1969 to add Chapter 157 Wind Energy Conversion System Ordinance.
5. **EFFECTIVE DATE:** This Ordinance shall be in full force and effect from and after its passage.
