

IT'S TIME FOR 2021 CITY-WIDE CLEAN UP!

LOCATED AT THE CORNER OF NORTH MAIN AND
JEFFERSON STREETS (VACANT LOT)

FRIDAY, JUNE 4 – 12:00n to 6:00p
SATURDAY, JUNE 5 – 8:00a to 2:00p

Residents should provide proof of current address
(for example, the JUNE 2021 water/sewer bill) **WITHIN CORPORATE LIMITS OF THE CITY;**
non-residents will be turned away.

GENERAL GUIDELINES

- Social distancing will be observed.
- Do not plan for assistance with lifting or placements of items in a roll-off canister, so bring your own lift help.
- Price for non-electric household items: **FREE!**

UNACCEPTABLE ITEMS are listed
on the reverse/second page.

- **Plan to be here early. People in line after the cut-off time may be turned away, as all containers will be removed on Saturday afternoon.**
- Tire recycling will be available on Saturday only, along the south edge of the tennis courts on Jefferson Street. Those recycling fees are \$5 per car tire and \$5-per-inch for semi/tractor tires.
- Lists of items NOT ALLOWED will be posted at City offices and online as well.

COM2 Electronic Recycling will be Saturday morning only from 9:00a-12:00n –OR– UNTIL FULL SO COME EARLY! Fees per item are:

- **\$20 per projection TVs**
- **\$10 per regular TV/computer monitor**
- **\$5 for all other permissible items**

Unlike last year, we will NOT accept electronic items before or after the designated truck is open/available.

Site will be monitored for dumping afterhours; please follow the guidelines to keep this event available in future years.



CITY-WIDE CLEAN-UP DAYS 2021

DO NOT ACCEPT LISTS

Items NOT allowed by the City and Advanced Disposal/WM to be included in regular Clean-Up Day containers include:

- Refrigerant-bearing household appliances (refrigerators, dehumidifiers, window air conditioners, wine chillers, etc.)
- Household hazardous waste (gasoline, solvents, pesticides, motor oil, pool chemicals, paint thinner, paint, etc.)
- Medical waste
- Mercury containing devices (thermostats, thermometers, etc.)
- Electronics (including computers, TVs and monitors)
- Yard waste and root balls
- Sod, rocks, dirt or concrete
- Batteries
- Fluorescent bulbs
- Tires
- Liquids and gases (propane tanks, fire extinguishers, etc.)
- Contractor construction debris (doors, windows, large amounts of lumber, masonry products, drywall, siding, roofing, water heaters, etc.)
- Propane tanks or equipment
- Burnt material/ashes of any kind
- Railroad ties
- Animals/carcasses



Items NOT allowed by the City and COM2 RECYCLING SOLUTIONS to be included in electronics cleanup containers include:

- Refrigerants (freon or freon substitutes, cars, compressors, air conditioners)
- Hazardous materials (oil, antifreeze, paint, etc.)
- Radioactive materials
- Non-electronics (trees, dirt, wood, asbestos, office waste, insulations, fiberglass, roofing, solid waste, furniture, etc.)
- Corrosives (batteries)
- Compressed gas cylinders (propane)
- Flammable materials (any kind)
- Other Hazardous Materials (pesticides, oil filters, mercury switches, fluorescent lights, air bags, lead)
- PCBs (capacitors, transformers, ballasts, etc.)
- Explosives (fire arms, ammunition, shells, etc.)
