**AN ORDINANCE AMENDING TITLE VII: TRAFFIC CODE OF THE CITY OF VILLA GROVE,  
ILLINOIS CODE OF ORDINANCES AS IT RELATES TO  
PARKING REGULATIONS AND PARKING SCHEDULES**

---

**WHEREAS**, the City of Villa Grove, Douglas County, Illinois (the "City"), is a duly organized and existing City created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto with full powers to enact ordinances for the benefit of the residents of the City.

**WHEREAS**, the City previously adopted Title VII: Traffic Code of its Code of Ordinances regulating parking and providing for parking schedules; and

**WHEREAS**, the City has considered input from the community and advice from its Police Department and has determined that it is necessary and in the best interest of the City and its residents to amend Title VII: Traffic Code of its Code of Ordinances as it relates to parking regulations and parking schedules all as provided herein.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and the City Council of Villa Grove, Illinois as follows:

SECTION 1: Incorporation Clause. The Mayor and City Council members hereby find that all of the recitals hereinbefore stated as contained in the

preambles to this Ordinance are full, true and correct and does hereby, by reference, incorporate and make them part of this Ordinance.

SECTION 2: Purpose. This ordinance is to amend Title VII: Traffic Code of the Villa Grove, Illinois Code of Ordinances as it relates to parking regulations and parking schedules.

SECTION 3: Title VII, Chapter 72.14: PARKING ON PRIVATE PROPERTY of the Villa Grove, Illinois Code of Ordinances is hereby created to read, in entirety, as follows:

“§ 72.14 PARKING ON PRIVATE PROPERTY.

(A) No person shall park any motor vehicle on private property without the consent of the owner of the private property.

(B) No person shall park any vehicle on private property except on a weed-free surface made of gravel, crushed stone, asphalt, Portland cement concrete, or brick pavers.”

SECTION 4: Title VII, Chapter 78, Schedule I: PARKING RESTRICTIONS of the Villa Grove, Illinois Code of Ordinances is hereby amended to now include the following:

<u>“Street</u>	<u>Location</u>	<u>Prohibited Times</u>
Main Street	Parking lot located at 123 N. Main Street	9 p.m. to 7 a.m. all 7 days a week”

SECTION 5. Headings. The headings for the articles, sections, paragraphs and sub-sections of this ordinance are inserted solely for the convenience of reference and form no substantive part of this ordinance nor should they be used in any interpretation or construction of any substantive provisions of this ordinance.

SECTION 6: Severability. The provisions of this Ordinance are hereby declared to be severable and should any provision, clause, sentence, paragraph, sub-paragraph, section, or part of this Ordinance be determined to be in conflict

with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable, and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect. It is hereby declared to be the legislative intent of the City Council that this Ordinance would have been adopted had not such unconstitutional or invalid provision, clause, sentence, paragraph, sub-paragraph, section, or part thereof had not been included.

SECTION 7: Superseder and Publication. All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded. A full, true and complete copy of this Ordinance shall be published in pamphlet form as provided by the Illinois Municipal Code, as amended.

SECTION 8: Effective Date. This Ordinance shall be in full force and effect upon passage and approval, as provided by the Illinois Municipal Code, as amended.
