Minutes Public Hearing and Special City Council Meeting November 3, 2022

PUBLIC HEARING HELD AT 5:30 PM ON NOVEMBER 3, 2022, IN COUNCIL CHAMBERS

A public hearing was held for discussion of possible bond issuance for the Community Center project build. Aldermen in attendance were Blaney, Johnson, Garrett, Pangburn, and Hooker (Cheely being absent). Also attending were Administrator Athey, Clerk Osborne, and Attorney Marc Miller. Mayor Eversole-Gunter called the hearing to order at 5:30 pm. No public members were in attendance. The tentative bond information is for borrowing \$3M, the interest rate would be 4.58%. The 10-year bond payment would be \$32,000/month; a 15-year bond would be \$24,000/month; and the 20-year would be \$19,000 per month. The hearing adjourned at 6:00 p.m.
