The gas line for the community building project was less than originally planned, which is good to hear, and Jacki signed the order for it. The tax levy amount is \$350,617.

DEPARTMENT HEAD REPORTS: Public Works: Director Randy Lake reported: noted a definite increase in the number of households needing leaf pick up as compared to last year.

Police Department: Chief Rea reports he will be out of office next week. He met with the school to go over responses for threats.

MAYORAL REPORT - The Mayor reported Alderman Johnson will pick up the Christmas Trees on Friday, and will need one person to help him from PW. Saturday, Nov. 19, 2022, will be the day the lighting committee will be working on decorations on Main Street-anyone who can join is welcome to do so-hands are needed!
