**AN ORDINANCE REVISING THE
2025 CITY COUNCIL REGULAR MEETINGS
FOR THE CITY OF VILLA GROVE**

WHEREAS, the City of Villa Grove, Douglas County, Illinois, is a municipality as contemplated under Article VII, Section 7 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of City's powers and functions as granted in the same; and

WHEREAS, the Mayor and City Council of the City of Villa Grove, Douglas County, State of Illinois, are charged with providing for the health, care and welfare of its citizens; and

WHEREAS, each year the City establishes the regular meeting dates for the City Council; and,

WHEREAS, 5 ILCS 120/2.03 provides for the City Council to amend its regular meeting schedule; and,

WHEREAS, the City Council and Mayor have determined it necessary and appropriate to amend the regular meeting dates for 2025 as provided herein consistent with 5 ILCS 120/2.03 and hereby affirm that it is necessary and appropriate to adopt the within ordinance.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL, CITY OF VILLA GROVE, DOUGLAS COUNTY, ILLINOIS, as follows:

Section 1. The foregoing recitals shall be and are hereby incorporated as findings of fact.

Section 2. The meeting dates for 2025 for the City Council meetings for Villa Grove, Illinois shall hereafter now be amended to take place at 6:00 p.m. on the dates listed as follows:

Monday, July 14, 2025	Monday, October 6, 2025
Monday, August 11, 2025	Monday, November 3, 2025
Monday, September 8, 2025	Monday, December 1, 2025

Section 3. The meeting dates for 2025 for the Committee of the Whole meetings for Villa Grove, Illinois shall hereafter now be amended to take place at 6:00 p.m. on the dates listed as follows:

Monday, June 30, 2025	Monday, October 20, 2025
Monday, July 28, 2025	Monday, November 17, 2025
Monday, August 25, 2025	Monday, December 15, 2025
Monday, September 22, 2025	

Section 4. Repeal of Conflicting Provisions. All ordinances, resolutions, and policies or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of the conflict, expressly repealed on the effective date of this Ordinance.

Section 5. Severability. If any provision of this Ordinance or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Ordinance is severable.

Section 6. Publication. The Clerk is directed by the corporate authorities to publish this Ordinance in pamphlet form. This Ordinance shall be in full

force and effect after its passage and publication in accordance with 65 ILCS 5/1-2-4. The Clerk is further directed and authorized to make publication of the within meeting dates in a manner consistent with 5 ILCS 120/2.03.
