**AN ORDINANCE CONCERNING ORDINANCE NO. 2022-MC11,
AN ORDINANCE AUTHORIZING AND DIRECTING THE ISSUANCE OF \$3,000,000

OF THE CITY OF VILLA GROVE, DOUGLAS COUNTY, ILLINOIS,
ABATING ALL OF THE LEVY AND EXTENSION OF TAXES FOR THE YEAR
2025 PREVIOUSLY ESTABLISHED TO PAY SUCH BONDS**

WHEREAS, the City of Villa Grove, Douglas County, State of Illinois, hereinafter “City” is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1, et seq.; and

WHEREAS, the City Council (the “Corporate Authorities”) of the City of Villa Grove, Douglas County, Illinois (the “City”) on November 28, 2022, passed and approved Ordinance No. 2022-MC11, An Ordinance Authorizing the Issuance, Sale and Delivery of General Obligation Bonds (Alternate Revenue Source), Series 2022, of the City of Villa Grove, Illinois and Authorizing Certain Other Documents and Actions in Connection Therewith, which provided details of such bonds and for an Alternative Source and the Levy of a Direct Annual Tax Sufficient to Pay the Principal and Interest of such bonds (the “Bond Ordinance”), which was filed with the County Clerk of the County of Douglas, Illinois on April 3, 2023; and

WHEREAS, pursuant to the Bond Ordinance, as supplemented and amended, including by this ordinance, the City, on April 6, 2023, issued \$3,000,000 of its General Obligation Bonds (Alternate Revenue Source) (the “Bonds”), with respect to which it is now established by Section 502 of the Bond Ordinance; and

WHEREAS, the City has reviewed its 2025 anticipated income from its tax levy, revenue from the State of Illinois, and other revenue streams together with anticipated expenses and has determined that it has sufficient funds with which to make its within referenced bond payments such that it is appropriate to abate the sums contemplated therein.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL, CITY OF VILLA GROVE, DOUGLAS COUNTY, ILLINOIS, as follows:

SECTION 1: Incorporation Clause. The Mayor and City Council of the City of Villa Grove, Illinois hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this ordinance.

SECTION 2: Abatement. That the tax levy provided in Section 502 of the Bond Ordinance be abated for the 2025 tax levy (to be received in 2026) as follows:

SECTION 3: Filing. As soon as this ordinance becomes effective, a copy hereof certified by the City Clerk, which certificate shall recite that this ordinance has been duly adopted, shall be filed with the County Clerk of Douglas County, Illinois, who is hereby directed to abate taxes as set forth above in Section 2.

SECTION 4: Acts of City Officials. That all acts and doings of the officials of the City, past, present and future which are in conformity with the purpose and intent of this Ordinance, are hereby in all respects, ratified, approved, authorized and confirmed.

SECTION 5: Superseder and Publication. All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded. A full, true and complete copy of this Ordinance shall be published in pamphlet form as provided by the Illinois Municipal Code, as amended.
